The complete rate quoted by the contractor shall be taken into account of all allowances for labour, hardness, wetness and all kinds of carriage, loading, unloading, total load and lift of soil involved to the entire satisfaction of the Engineer-in-Charge confirming fully to the specification No. 6.2 & 6.3 of Haryana PWD specification 1990 including subsequent agenda and corrigenda issued from time to time. **CONDITIONS**

1. The quotations should be submitted by 8.02.12 upto 2.00pm in the office of the Principal, AI Jat HM College, Rohtak.
2. The quotation will be opened in the office of the Principal, AI Jat HM College, Rohtak in the presence of the agencies or their representative/s who may like to be present at that time.
3. After finalisation of the agency/contractor on lowest quotation basis or further negotiation if any and before starting the work, 2% earnest money of the estimated cost will be required to be deposited by that firm in the shape of the Demand Draft in favour of the Principal, AI Jat HM College, Rohtak.

4. Conditional quotation is liable to be rejected.
5. In case, tendering day happens to be a holiday, the quotations will be received/ opened on next working day at the same time.
6. The contractor/agency should furnish the list of machineries/ equipments related with the works with the quotation.
7. The work may be withdrawn from further processing at any stage at the discretion of the competent authority without assigning any reason.
8. Nothing extra whatsoever shall be paid on account of losses, damages done by rains or any other natural calamity.
9. The building committee of the college reserves the right to accept or reject or negotiate any of the tender or conditions/items without assigning any reason thereof.
10. The building committee of the college is competent to increase/decrease the quantity of the work.
11. The tenderers are advised to visit the site sufficiently in advance to the date fixed for submission of the quotation. The agency shall be deemed to have full knowledge of all the relevant documents, samples, sites etc. whether he/she inspects them or not.
12. 10% security will be deducted from the running bills subjected to the maximum of 5% of the estimated cost and it will be refunded as under:
  - a. 75% of the security deducted will be refunded after three months of the completion of the project.
  - b. Balance 25% will be refunded after one year either at the completion or final bills whichever is later.
13. The taxes will be deducted from the bills of the contractors as per Govt. rules amended from time to time.
14. The defects liability period will be one year after completion of the project.
